TRIBAL ELECTION *Candidates*

There are ten candidates for this year's Tribal election. Of these ten candidates, three will be elected by the General Council to serve on the Tribal Council for a term of three years. The ten candidates are: Stephanie A. Bryan, Peggy Rolin Couch, Helen Hallman (Incumbent), Ronnie Jackson, "Poncho" Douglas Kelley, Keith Martin, Daniel McGhee (Incumbent), Fred L. McGhee, (Incumbent), John Arthur McGhee, "The Corn Man", and Garvis Sells.

The following are bios and statements submitted by the candidates.



STEPHANIE A. BRYAN

I, Stephanie A. Bryan, hereby declare my candidacy for the 2006 Tribal elections. I am the daughter of Julia Ann Stacey (McGhee) and Donald Ray Abney. My grandparents are the late Doris (Buck) and Lunie Mae McGhee (Presley). I am married to Keith L. Bryan and we have three children: Keisha, Brannon, and Nikki.

My decision to run for Tribal Council was solely based on my love for people. I feel I have the educational background to make good financial decisions in order for our Tribe to prosper. My experience and knowledge I gained while working for the Tribe numerous years ago will be an asset. While working for the Tribe, I was able to assist in writing grants, proposals, policies and procedures, and resolutions.

I would like for every Tribal Member to know that I am a person that can make decisions on my own, and I am definitely not easily persuaded by no one. I will make my decision with the General Council in mind at all times. If it were not for the General Council, there would be no Tribal Council. The interest of my people will always be the number one priority.

These are a few economical developments and issues I would love to see addressed if elected:

Nursing home/assisted living facility-If it were not for our elders, we would not be here today. Let's take care of them and support them.

Healthcare-I would love for the Tribe to be able to offer a universal health care plan for all Tribal Members, even those outside the five county service area. Some people choose to live in other states and counties due to great economic growth and opportunity to be successful so, therefore, they should not be punished. They are Tribal members too. (I feel this way about all programs that are available for Tribal Members such as Housing, etc.)

Credit Union-Let your own money work for your own society and community.

Indian Descent-They are allowed to play sports and have health

care provided until age 18, but it should not stop there. If they are Indian Descent (first generation) they belong to a Tribal Member, therefore, you are helping a Tribal family. They have NO assistance with education and that should be very important.

Lowering the age for the Senior disbursement.

Education-Educating our own people to be successful leaders is a must. I am thankful for the affluence in the department that has taken place this past year. But consider something for our Indian Descent children. It may not be equivalent to the Tribal Members, but something is better than nothing.

The above things are just a few things I would like to see happen, but what matters is what YOU, the General Council, would like to see happen. I am just one and cannot accomplish all these things alone so, therefore, it is important that we have a Tribal Council that will work together for the prosperity of this Tribe. So, in closing, I ask that you please consider me as one of your candidates on June 3rd. Thank you in advance for your vote and support.



PEGGY ROLIN COUCH

I, Peggy Rolin Couch, hereby announce my candidacy for the 2006 Tribal Council Election.

Fellow Tribal Members,


I would like to remind you to exercise your right to vote in the upcoming Tribal Council Election on Saturday, June 3, 2006 at the SAIL Center.

"PONCHO" DOUGLAS KELLEY



Henci (hello), I am Tribal Member Douglas Kelley (nicknamed Poncho), and I represent the ordinary Tribal Member. I represent the person without a lot of money, the person who struggles to make ends meet, the single parent who is concerned about the education of their children, the person who is tired of favoritism, the Tribal Member whose voice has not been heard.

I am fifty years old and grew up in Canoe, Alabama. I am the son of Lillie Mae Colbert and John O. Kelley of Pollard. I am the grandson of Hattie and Owen Colbert of Uriah (on my mother's side), and Ida and Henry Kelley of Bratt, Florida (on my father's side). I was baptized when I was eighteen in Bethel Baptist Church in Flomaton. I follow the principles that my parents taught me as a child which include looking out for others and not only for self.

I am the father of three children, and the proud grandfather of two children. I am the proud parent of a son who served in the US Army in both Iraq and Afghanistan. On May 20, 2006, I will unite my family with Deidra Sawanee Dees' family when we get married in a traditional Muscogee wedding at the ceremonial stompdance grounds.

I have worked hard-labor jobs all my life, specializing in oilfield labor throughout the southeast, as well as offshore drilling rigs in the Persian Gulf. These jobs were often dangerous and instilled in me the importance of teamwork. I learned that when we work as a team, we produce a higher quality product which represents the whole group and not the individual, and we protect each other from harm while we work. I currently work as part of a ranch hand team at Perdido River Farms where I help take care of about 300 head of cattle. I have observed some positive and negative traits in the cows that our team takes care of. I have seen mothers that are very protective of their young, walking close beside them, providing them nourishment, never letting them out of their sight when coyotes are around. But I have also seen greed in some of the bigger cows that push other ones aside, so they can get more than their share of food from the trough. Sometimes humans show these same positive and negative traits. With your vote, I will work as a team member along with you, nurturing the positive traits of our community, keeping the fat cows from taking more than their fair share, so that our community can grow stronger and be protected from harm.

My family and I have shown our commitment to our community by spending time with our youth and by participating in community events such as our community meetings, our stompdance gatherings, and our education programs. For the past ten years I have demonstrated my leadership abilities in serving as Henehv (a Muscogee word meaning second chief) at our ceremonial stompdance grounds where our community members follow the ways of

those who came before us. In this leadership position, I am required to hear everyone's concerns, to not be partial, and to make decisions for the good of the whole community and not the individual. Many people have complained about favoritism in our Tribe which has harmed our community. I am not closely kin to any employees of our Tribe or any of our Council members, therefore, voters will not have to worry about me using favoritism to advance myself or my family. Instead, I will use the skills I have learned from my parents, on my jobs, and at the ceremonial grounds to represent the voices of our community in a fair, honest, and impartial manner.

Drugs and alcohol, enemies to Indians, have stolen the lives of so many of our team members, robbing them of their rightful place in our society as productive members. If part of our community is sick, our whole community suffers. What if a Tribal Member overcame drugs and became a medical doctor working along side of Dr. Parker Estvold at our clinic? What if a Tribal Member conquered alcoholism and discovered how to heal people from Cancer. Imagine the great benefit this person would be to us and to the world! As a person who has been free of alcohol for over fifteen years, I will support drug and alcohol abuse programs to help members of conquer these enemies. Then they could use their God-given talents to help heal our community as a whole and make our team stronger.

As a Tribal Council member, I will work to strengthen health-care benefits for our elders, to expand education programs for our youth, to develop economic opportunities for our members, and to examine the ways gaming profits are used in our community. Tribal Members need to know how our money is being spent. You need control over what is happening to *your money!*

In the old days, our elders on the Council sat around the council fire making decisions that impacted the whole community. Back then it was a distinguished honor to be given a place on the Council. I too would be honored for the privilege of serving you on our Tribal Council. I will represent your voice by listening to your ideas and by bringing your concerns before our Council and before our Tribe. I will give voice to those who have been unheard. You have voted for assimilated Indians before and nothing has changed. Why not vote for a traditional Indian this time? Douglas Kelley is the candidate who represents YOU.

I have served two terms on the Tribal Council before. This was when we were less successful and much smaller. And times were a lot harder.

I've worked very hard for this Tribe in many different ways. I've worked for the Best Western hotel for years. Some of you know me as the "Corn Man", because I've roasted corn for many years at our Thanksgiving Pow Wows and special events.

If elected I will support the need for health insurance for Tribal Members. Using myself as an example, a majority of Tribal Members are self-employed or employed by small businesses which can not afford the high cost of health insurance. By the Tribe offering this service it will not only put needed income back into the family, but will lessen the strain on the current Tribal health care system. It will also allow those outside the immediate service area to obtain health care.

Another concern I have is the volunteer fire fighters. The Tribe should be more appreciative of those individuals who give time and put their lives at risk for the benefit and safety of our community. These volunteers are called out at odd hours, including nights and weekends and are expected to put in a full day's work at their respective jobs. Often these individual aren't given any support or a simple "Thank you". The community needs to be more supportive and aware of the dangers these fire fighters face when out on a call. It's a department one takes for granted until needed. For example, when my son was ill 911 was called-the department responded within minutes and for that my family was most grateful.

I also feel that it is time to have our Tribal service area re-evaluated. We have a large number of Tribal Members currently living in Santa Rosa County, Florida who would benefit for our existing Tribal services.

If elected, I will be fair and treat everyone equal. Thank you for your vote.

DRUG COURT MONTH MAY 2006

Please join the Drug Court Team and Tribal Court staff in celebrating National Drug Court Month in May. The Tribe's drug court has been in operation for approximately seven (7) years. The Court was funded through a three year grant in 1996 by the Department of Justice. The PBCI Tribal Drug Court was recognized in 1998 as a mentor court by the National Association of Drug Court Professionals. The federal funding was exhausted in 2003 and the Tribe has taken over all funding for the Drug Court Program since that time. The Tribal Drug Court Program has had 44 participants with 21 graduating, 14 terminated for violations of program procedures, and 9 current participants. To be considered a candidate for participation in the Tribal Drug Court a Tribal Member or first generation descendant must be charged with drug related crimes. After being accepted into the program, the participants are placed into an environment where they undergo treatment and counseling, submit to random drug testing, and regular appearances before the Tribal Judge and are monitored closely for program compliance. Sanctions are imposed for noncompliance including jail time, community service and fines. Incentives are also applied for continual compliance.

The Drug Court Team is very proud of the accomplishments that have been made in the last seven years and looks forward to many more accomplishments in the years to come. Current Drug Court Team members include; Kim Snow, Human Services Coordinator, Sandra Hiebert, Education Executive Director, Wes Hayles, Drug

PROPOSED CONSTITUTIONAL AMENDMENTS

Pursuant to Article IX, Section 1 of the Constitution, the Tribal Council submits two proposed amendments to the Constitution for a vote by the General Council at the June 3, 2006 election.

The first proposed amendment relates to the Tribal Council's ability to amend and repeal ordinances and resolutions. Under the current Constitution, although the Tribal Council can enact ordinances or enact, amend, and repeal resolutions by a majority vote, the Tribal Council cannot make necessary amendments to ordinances or repeal outdated ordinances without a majority vote of at least thirty (30) percent of qualified voters at either the annual election or a special election. This restriction hinders the Tribal Council's ability to comply with changes in the law and respond to changes in circumstances. This language is also inconsistent with the way in which federal and state statutes are made, amended and repealed. (Because Congress enacts a federal statute, Congress can also amend or repeal a federal statute without a vote from citizens.) To keep the standard high for enacting, amending, and repealing ordinances but also enable the Tribal Council to make necessary changes, the Tribal Council proposes that Article V, Section 2(F) of the Constitution be amended such that the Tribal Council can amend or repeal ordinances by a two-thirds vote of the total membership of the Tribal Council. The proposed language would read as follows:

(F) All final decisions of the Tribal Council on matters of general and permanent interest to the members of the tribe shall be embodied in ordinances. The Tribal Council shall enact, amend or repeal an ordinance only by a vote of two-thirds of the total membership of the Tribal Council. The ordinances shall be collected and made available to tribal members and other affected persons upon reasonable request.

In order to clarify that the Tribal Council may continue to enact, amend, or repeal resolutions by a majority vote (as they have been doing under the current Constitution), the Tribal Council proposes that Article V, Section 2(G) of the Constitution be amended as follows:

(G) All final decisions of the Tribal Council on matters of temporary interest shall be embodied in resolutions. The Tribal Council shall enact, amend or repeal a resolution by a majority vote of the Tribal Council. The resolutions shall be collected and made available to tribal members and other affected persons upon reasonable request.

The second proposed amendment relates to the Tribal Council's ability to remove a Tribal Council member. The Tribal Council currently has no authority to remove a Tribal Council member under any circumstances. For example, even though a candidate in an election cannot have a felony conviction, the Tribal Council cannot remove a Tribal Council member if he or she is convicted of a felony while serving in office. The proposed amendment to Article IV, Section 4, of the Constitution would read as follows:

(Q) Remove any Tribal Council member convicted of a felony or enforce any order to remove a Tribal Council member for an ethical violation in accordance with the Poarch Band of Creek Indians Ethics Code and fill that position in accordance with Article 7, Section 8 of this Constitution.

Muskogee Metalworks Receives 8.8 Million Dollar Contract

Muskogee Metalworks, a subsidiary of Creek Indian Enterprises, has received an 8.8 million dollar contract with ITT Industries Night Vision Division to produce night vision goggle kits for the U.S. Army. According to Mal McGhee, General Manager, "This contract will go a long way in helping Muskogee get back into the black, because we have made a very significant investment in our plant, tools, and equipment. We look for this contract to be just the beginning of many with ITT Industries." "Lean and mean," Mal said, "this is how we are going to get ahead. We have recently lost some of our Administrative staff; but this has been a good thing, it has helped our overhead. As we go forward we will eventually bring these positions back on."

In the past few months I have spoken with Mal a couple of times about doing an article about Muskogee Metalworks for the Tribal Newsletter. It is a coincidence that I met with him on the day he made the contract announcement to his employees. Mal has always voiced an interest in doing an article; he says that Muskogee Metalworks has been exhibited at the Pentagon, featured in many local newspapers, and been highlighted on several local TV news programs, but that they have never been featured in the Tribal Newsletter. My trip to Muskogee was quite an experience. I am not sure about you, but I was not sure of exactly what MUSKOGEE does; I kept thinking "They make nuts and bolts." Well, needless to say, that is not exactly true; sure they produce some nuts and bolts, but that is a miniscule portion of the productivity of Muskogee.

The Tribe purchased Strader Manufacturing, located in Milton, Florida, in 1988. In January of 1993 the company relocated to Atmore and changed its name to Muskogee Metalworks. Muskogee moved to its current location when the Tribe purchased the Vanity Fair building, located in the very heart of Atmore, in 2003. Many of our local ladies are very familiar with this location, as many of them worked at Vanity Fair for many years. Mal McGhee has been with the company since 1992. He is proud to be a part of the company and has been excited to see it grow from its humble beginnings to the technologically advanced company it is today by being successfully competitive in the fields of kit production (night vision goggles, C-5 kits, etc.), metal working, (welding, water

cutter, etc.), and electronics (cables & harnesses).

Although there are still a couple of manual machines in the shop, Muskogee is increasing its number of CNC (Computer Numeric Control) machines, which uses computers to do the work that once was done by hand by a machinist. I met Todd Gookin at one such machine, he demonstrated the relative ease of operation of a CNC machine. I was very surprised to later find him in the Programmer's office. He is one of the Programmers for Muskogee! He laughed when I told him I was surprised to see him at his computer. He told me that you have to be a Machinist to be able to create the program. Mal would like to encourage Tribal Members to use their educational tuition assistance funds to get a college degree in the field of technology, it is ever growing, always in demand, and is a degree that can be used right here at home.



“Wall Of Fame”, which displays various newspaper articles, commendations, and awards that has been duly earned by Muskogee in addition to samples of the products they produce. Entrance into the facility is secure due to governmental requirements; visitors must sign in at the reception area and receive a visitor’s pass before proceeding into the plant area. Muskogee has several governmental contracts which require a high level of security. A government safety inspector recently toured the facility and gave it high marks. The minor deficiencies have been addressed and Muskogee has been classified as an approved property control location. All welders at Muskogee are certified welders, which is a huge asset when making competitive bids.

Muskogee has major contracts with ATA, at Arnold AFB (Tennessee), NASA/Wind Tunnel Projects, the Defense Supply Center, U.S. Army, Northrup Grumman, Warner Robbins AFB, where they are producing Emergency Power Generating Upgrade kits for the C-5 Military Aircraft, Electronic Junction Boxes for the AC-130H Gunship, and Eglin AFB for whom they are making Bunker Buster Bomb Pallets. They also have commercial contracts with the Southern Company.

Campground amenities (some amenities may not be available at present time), include: 27 campsites with water and electricity; primitive campsites; dump station; bathhouse with hot showers (under construction); laundry room (to be constructed); three group pavilions with tables, fishing, hiking trails; horseback riding; volleyball court; horseshoe pit; tubing and swimming in creek (at your own risk-no lifeguards on duty); and 50/30/20 AMP service.

Rules and general information (some amenities may not be available at present time):

OFFICE HOURS: Office hours are from 7:00 a.m. to 7:30 p.m. Messages may be picked up at the office. Look for your name on the message board located on the front porch. Emergency messages will be delivered.

Reservations: All campers must register at the office on arrival. Rentals fees are payable in advance. Guests desiring to extend their stay should inquire at the office by 10:00 a.m. to see if accommodations are available; reservations take preference over change of plans. Call (251) 446-3423 or (251) 368-0819 for reservations and/or information.

CONDUCT: Persons guilty of disorderly conduct or vandalism will be asked to leave the grounds. Guests are responsible for losses, damage, or injury to persons or property caused by their negligence. Illegal drug use or alcoholic beverages are not allowed and will not be tolerated. We reserve the right to evict anyone violating the rules of good camping, destroying property, or creating disturbances. Parents are responsible for seeing to it that children obey all the rules at all times. Glass containers are not allowed on the beach or in the water.

QUIET HOURS: Quiet hours are from 9:00 p.m. to 8:00 a.m. Please be considerate of your neighbors at all times.

CHECK OUT: Check out time is 1:00 p.m. Please notify office upon departure. Refunds will be made at management's discretion.

SPEED LIMIT: The speed limit in the park is 10 MPH. Speeding will not be tolerated.

SITES: Keep your site neat and orderly. Please do not put nails in trees when hanging clotheslines. Campfires are allowed only in designated areas.

GARBAGE: Must be sealed securely and placed in provided dumpsters. Please dump Port-a-Potties, gray and black water, at dump station, not on our ground.

RESTROOMS: Please help keep restrooms and showers neat and tidy. Please do not clean pets, dishes, laundry, or recreation equipment in our restrooms. Children under the age of ten must be accompanied by a parent.

PETS: We feel your pet is part of your family, but please keep it on a leash, away from the swimming area, and out of restrooms, showers, and laundry room. Please clean up your pet's "poop". Quiet, leashed pets are "welcome".

VISITORS: Visitors are allowed at campsites with a pass only.

scaped and is very attractive. Billy Smith stated that they are hoping to purchase Master Camper software to help them manage the campsite rentals, etc.

The shower facility is under construction and should soon be completed. Twenty blue bird boxes have also been built from juniper logs and placed all along the roadway leading to the picnic area. Bill English, Tribal Member and Reserve employee, made and hung each of the boxes. More duck boxes are needed and will soon be built and placed around the lakes throughout the Reserve. Hawks are nesting and wild turkeys are abundant.

Stepping Stones, the first of the hiking trails has been completed. Stepping Stones is a three and a half mile hiking trail running from the entrance to the picnic area and through some of the back off-road areas. You can park your car at the entrance, or any of the parking areas along the way, and hike the trail by following the blue rings around the tree trunks or posts. The trail is circular so wherever you start, you will always end up in the same place, as long as you follow the trail.

Logging crews are working at clearing some of the trees damaged by Hurricanes Ivan and Dennis. It is the Reserve's long term goal to remove all debris and clear out the old undergrowth so that new undergrowth can come in. It is the goal of the Reserve to have its forest like a national forest and have it considered a "Treasured Forest".

There are still a great many plans for the Reserve, and we look forward to seeing you along the creek.



LEGAL NOTICE

On March 14, 2006, Community Recovery Services, Inc. ("CRS") filed a complaint against PCI Gaming in Tribal Court. CRS asserts, among other things, that PCI Gaming breached its contract with CRS with respect to improvements at Riverside Entertainment Center by refusing to pay in full or at all certain invoices and demands over \$2.1 million in damages. In October 2005, PCI Gaming hired an independent firm to conduct a preliminary audit regarding construction costs related to the Wetumpka Project, including certain costs submitted by CRS. The preliminary audit showed that PCI Gaming may have been overcharged in an amount that exceeds CRS' demand, but the auditors needed additional information from CRS. PCI Gaming requested earlier that CRS provide the additional information, but CRS failed to respond. Instead, it filed this lawsuit.

PCI Gaming believes that CRS' complaint has no merit, especially given the preliminary audit findings, and filed an answer and affirmative defenses against CRS' claims on April 3, 2006. In its pleading, PCI Gaming also asserts counterclaims against CRS. PCI Gaming alleges that the June 11, 2004 contract and subsequent change orders are not valid and enforceable because an agent, servant, or employee of CRS who was also an officer, agent, servant, or employee of PCI Gaming improperly attempted to enter into and/or execute them, and seeks damages for PCI Gaming's overpayment of CRS for actual work and/or labor performed. In the alternative, PCI Gaming asserts that CRS breached the contract by failing to build the improvements at Riverside in accordance with the terms of the contract and seeks damages for that breach. Finally, PCI Gaming asserts a fraud claim against CRS for misrepresentations made regarding the work and labor performed and amounts due and seeks compensatory and punitive damages against CRS.

On the same day that PCI Gaming responded to CRS' complaint, PCI Gaming also served discovery requests on CRS to obtain the information that PCI Gaming needs to complete its audit and to gather additional factual information for its defense against CRS' claims and the litigation of its counterclaims. PCI Gaming will continue to defend against CRS' claim and to attempt to recover any and all damages suffered by PCI Gaming with respect to the Wetumpka Project.
